The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II for the Academic Years 2018-19 to 2020-21 i.e. up to 30-06-2021 and for which the concerned Institutions have submitted Compliance Reports, but the visit of Expert Team for data verification of the programs is pending because of the current pandemic situation due to Corona virus, the programs will be considered for accreditation of one year i.e. up to 30-06-2022 after data verification of the programs internally on the basis of the submitted Compliance Reports. The data submitted by **Adi Shankara Institute of Engineering and Technology, Vidhya Bharathi Nagar, Mattoor, Kalady-683574, Ernakulam district, Kerala** in the Compliance Reports has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Adi Shankara Institute of Engineering and Technology, Vidhya Bharathi Nagar, Mattoor, Kalady-683574, Ernakulam district, Kerala** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

5. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.

6. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
